Q What is your name?  
A Henry Pean. (Sworn)  
Q Have you any other name?  
A Chiu Hing Lee.  
Q How old are you?  
A 29.  
Q Where were you born?  
A Alexandria, Virginia.  
Q What was your father's name?  
A Chiu Pean.  
Q What was your father's Chinese name?  
A Chiu Chuck On.  
Q Did you ever have any brothers born in the United States?  
A Yes, George and Charlie, both dead, they were born in Alexandria.  
Q Did you ever have any sisters?  
A No.  
Q What is your mother's name?  
A I don't know.  
Q Do you know what nationality your mother was?  
A White race.  
Q Where is your father?  
A In China.  
Q Where is your mother?  
A She is dead.  
Q Where in China is your father?  
A Har Loo, Hen Low.  
Q Have you any papers showing your birth in the United States?  
A (Presents certificate of identity No. 7000 issued to Henry Pean, (Chiu Hing Lee) at Vancouver, B. C., July 18, 1912, by John L. Surbrick, Immigration Official in Charge.)  
Q Through what port do you intend to depart?  
A Vancouver.  
Q Are you married?  
A Yes.  
Q What is your wife's name?  
A Jung She, natural feet, she is in China.  
Q Where in China is her native village?  
A Duk Jow.

Q Where is your wife living at the present time?  
A Har Loo, Hen Low.  
Q Was your wife ever in the United States?  
A No.  
Q Have you any children?  
A One boy, Jew Jon, 3.  
Q Is that the only child you ever had?  
A Yes.  
Q Did you ever have any adopted children?  
A No.  
Q As a U. S. citizen have you ever exercised your right as such to vote at any election?  
A No.  
Q Do you read and write the English language?  
A A little.  
Q You speak it some?  
A Yes.  
Q Have you ever been a witness in this office or any immigration office or court in a Chinese case?  
A No.  
Q Have you understood all the questions asked you?  
A Yes.
